Re: To request the committee to recommend to council, amending the lease agreement between the Township of Wellington North and Mount Forest Victory Church located at 320 King St. East (former Mount Forest Community Centre).

Requested amendments:

- To renegotiate the renewal period beginning Aug.16, 2019 from a 5 year lease to a 100 year lease. (Article 1.5 lease agreement)
- To remove the \$500 a month lease rate attached to our renewal for 2019. (Article 1.7 lease agreement)
- To remove "termination by the Township without cause" (Article 6.2 lease agreement)

Current scope and use of facility:

- 1. Victory Church has occupied the building for almost 10 years and fulfilled all the terms of the lease agreement. The approximate expenditure, including labor, is \$80,000 at no cost to the Township.
- 2. Victory Church, in partnership with the Township, has established and manages the Wellington North Farmer's Market (2019 is the 6th season) which uses the facility weekly for washrooms and hydro. The arena floor is used for rainy days.
- 3. Victory church has committed, as per article 1.2.1 & 1.2.2, the use of facilities and storage of equipment to the M.F. Agricultural Society and we intend to continue this agreement. For the 2018 Mount Forest Fair the church ran a "kid's zone" which we have committed to doing again for 2019.
- 4. Various groups now use the facility, including: Wellington Roller Derby; Friends of Pickle ball; Off ice hockey training; umpire clinics; baseball clinics; children's floor hockey; agricultural society; teen dropin; Victory Youth group; Fur and Feather; various single use groups; School groups; Mount Forest Christmas Bureau and, of course, Mount Forest Victory Church.

Reason and vision for our request:

Since occupying the building in 2009 we have seen the vision for our church develop into a strong connection between local government, the people, and Victory Church. These connections have developed an amazing relationship that has helped us to see how we can add value to our community and Township. Admittedly, we never realized how a building could be such an integral part of developing such a relationship. So many people have let us know of their past connections to this building and are happy to see it continue for community based uses and, as a church. Having seen as a

Church how this has developed we are so appreciative of the privilege and opportunity the Township of Wellington North has given us through this partnership.

We want to develop these partnership opportunities further and grow the value added to our community through a long term lease agreement. This will give us the confidence to invest more money into the repair and maintenance of the building and realize the "fruit of our labor". Like the Township; our vision for the church and community is long term. We see the new growth happening in Wellington North and understand there must be a long term strategic plan. Victory Church wants to be a part of that plan where we can facilitate, and celebrate, that growth.
