## DISCLOSURE OF PECUNIARY INTEREST(S) AND THE GENERAL NATURE THEREOF

No declarations of pecuniary interest were declared

#### DELEGATION

Mount Forest Patriots Derek Bridgewater, President Rob Nixon, General Manager

Mr. Bridgewater and Mr. Nixon appeared before the committee to express their concerns regarding the Greater Metro Hockey League (GMHL) bringing a Junior A team to Wellington North.

 The GMHL is an outlaw league and is not sanctioned by the Ontario Hockey Association (OHA) nor by Hockey Canada. The OHA and Hockey Canada governs the majority of hockey teams in Canada and they have very specific and

rigid rules and regulations that must be adhered to. The GMHL seem to make their own rules as they see fit.

- A GMHL team would infringe on the Patriots drawing area and sponsors. The
  Patriots have a designated area for recruiting players and are only allowed four
  imported players each season. Imported players are from within Ontario. The
  GMHL would drastically diminish the Patriots resources as a Not For Profit
  organization and impact sponsors.
- GMHL rosters show the vast majority of players come from the United States and Russia. Questions regarding the players: Who pays the billets? Have the players completed school? Are they productive in our community? Who holds them accountable?
- The Patriots pay hefty insurance premiums with the Wellington North named as a rider. Proof of insurance must be given before they even step on the ice. Will there be guarantees that the Township won't be liable in the event of an injury to a player or spectator? Who is responsible for the premiums and will there be adequate coverage?
- The NHL considers the GMHL to be sub-par, importing castoffs or kids from non-traditional hockey countries looking for better competition. There is little hope of a GMHL player having a future career in hockey.
- There are reports of the GMHL recruiting teenagers to further their dreams in a non-sanctioned league where fees, room and board, etc can cost up to \$20,000. The parents of a 19 year old Russian playing in Shelburne bankrupted themselves getting their son to Canada and it still wasn't' enough. He owed the team \$3,500.00 and it was only through media readers donations that got him out of debt.
- Many foreign GMHL players are not in school and end up in small rural towns that are strange to them and they are not always welcomed and they do not contribute to the community. The league does not have a policy or strategy to help players acclimate to their new environs and attrition is frequent.
- The OHA Junior hockey program is designed to develop players, many of which will move up to a higher level of hockey. Teams under the OHA umbrella have a continuous stream of legitimated scouts at their games watching progression of players.
- The OHA in not in it for the money. A recently implemented registration fee of \$300. that goes towards the OHA's overhead, staffing and the AGM. The teams do not benefit from the fee.
- New mandatory programs for players and personnel are constantly implemented. A Prevention Services Officer talks to players multiple times during the season about their rights. He has completed qualification courses and is at arms length from the team to ensure there is no bias. There is a zero tolerance regarding hazing and a strict policy regarding drugs and alcohol. A code of conduct must be followed on and off the ice. The entire Patriot's team have completed the Safe Talk program which teaches suicide awareness and next steps should you be concerned about someone committee suicide. The GM completed a mandatory nutrition course this season. The Patriot's have a team Doctor, Physiotherapist, Pointstreak Technician, Announcer, Trainers, Equipment Manager, President &

VP, Treasurer, Secretary, etc. who are all volunteers that do it for the love of hockey, our team and our community. You will not find the same in the GMHL.

Mayor Lennox questioned the impact on player recruiting. The GMHL left an impression that there would be little impact on the Patriots. Mr. Nixon explained that the GMHL say they won't infringe on players but they have already contacted 6 of the Patriots players. They put pressure on players by creating a "What can you offer" attitude to create competition. The GMHL makes empty promises to potential players and then don't follow through. The OHA has stability. The GMHL stability relies on payment for support. They use a Junior A title that is not fitting to the caliber of hockey played. Players from the GMHL are banned from OHA teams. The GMHL also uses the same tactics with sponsors.

Mayor Lennox commented that the GMHL is not counting on revenues from attendance because it is a pay to play league. Mayor Lennox asked Barry Lavers, Director of Recreation Parks & Facilities, if he had obtained information regarding other GMHL teams. Mr. Lavers explained that the GMHL is new in Grey County. Meaford sold their team back as the people in Meaford had to carry them. There are teams in Markdale and Feversham. The Towns are unlikely to buy into those teams. The team in Feversham is experiencing problems and may move out because of lack of fan support.

Councillor Burke asked how many GMHL players are local. Mr. Nixon explained that 70 to 80% of the players are Russian. There are three teams in Grey County and only one boy is local.

Mr. Bridgewater asked that the Committee keep the Patriots aware of what is happening.

#### **BUSINESS ARISING FROM MINUTES**

Councillor Burke asked about the status of the staff report regarding the Greater Metro Hockey League. Barry Lavers, Director of Recreation Parks & Facilities, stated that he was waiting for the presentation from the Patriots. He has not been able to reach the Arena Manager from Markdale but has more information with regards to Feversham. Mr. Lavers stated that discussion may have to take place during a closed meeting session.

Councillor Burke questioned the fee for Non-Prime Ice. She would prefer the rate to be the same as the fee charged for minor sports. Mr. Lavers explained that in 2014 it was decided that the Non-Prime Ice rental rate would be raised in three equal increments over a three year period to eventually equal the Minor Sports rate. This year is stage two of the increase.

Committee reviewed the 2016 Recreation Fee Schedule. Direction was given to staff to determine the actual cost of the soccer pitches and ball diamonds.



Trail Funding Request - Wellington North (PD2015-32)

#### 1. Purpose

The purpose of this report is to consider a \$20,305.00 trail funding request from the Township of Wellington North to support improvements to the Upper Grand Trailway – West Luther. This rail trail connects the River Trail in Arthur running east to the Upper Grand Trailway at Township/County limit. The trail is also a priority identified in the County of Wellington Active Transportation Plan.

Figure 1 Location of Upper Grand Trailway – West Luther



#### 2. Trail Funding Programme

The Wellington County Trail Funding Programme was approved by County Council in February, 2015. The programme allows for matching funds up to \$50,000 per municipality to be applied to one or more municipally endorsed projects matched by the municipality or community groups. The programme ends November 30, 2018.

The Arthur Trails — West Luther project includes 3 km of trail surfacing, 2 bridges, barrier gates/posts, signage, and tree planting. The Township's request is to match the \$20,305.00 raised by the Arthur Trails — West Luther Group for a project totaling \$43,431.17 (see Appendix 1 Budget).

If this request is approved, there would be \$29,695.00 remaining in the funding programme for Wellington North.

#### 3. Recommendation

#### **BACKGROUND**

Following the Recreation & Culture meeting of September 15, 2015 there were 2 outstanding capital projects not completed.

#### FINANCIAL CONSIDERATIONS

#### **Mount Forest Ball Diamond Fencing**

\$6,000 was approved within the 2015 capital program for this project.

Fencing work was completed by B.L Farm Services at a cost of \$5,900 in November 2015.

#### **Mount Forest Water Treatment System**

\$5,400 was approved within the 2015 capital program for this project.

The water treatment system installation was completed by Custom Blend Treatments at a cost of \$5,891.52 in November 2015 with the exception of a connection coupler to the existing water line which is currently on back order. Completion is expected shortly.

Mayor Andy Lennox and Council Members:

As President of the Mount Forest Agricultural Society, along with my fellow Directors, I would like to bring what I feel is an important issue to your attention.

In the Mount Forest Fairgrounds, on the east side backing onto Newfoundland Street, there is an area approximately 250' x 200' that has been left unattended by the Recreation Department when mowing and trimming the surrounding Fairgrounds/park. This is a fenced-in area accessible by two 8' gates at the north end. It is an area used by the Society to judge Western Horse Shows during the Fall Fair. A similar area approximately 50' x 60' directly north of this aforementioned area, which is used as a warm-up ring at the Fair, is maintained and mowed on a weekly basis along with the rest of the Fairgrounds/park. Neighbours have complained and residents using the track have also expressed concern when the rest of the grounds are so well manicured. In comparison, the Arthur Fairgrounds which are used for their Fall Fair are cut and trimmed every week and are a show piece for them to be proud of.

In closing, Mount Forest is a picturesque town that we are very proud of and we need to step up to the plate and bring the "entire" Fairgrounds/park in line with the rest of the town.

WHEREAS the Town is the owner of the lands described in Schedule "A" annexed hereto, and the Society wishes to use the said lands from time to time.

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of the covenants contained herein and other good and valuable consideration the parties hereto agree as follows:

- 1. The Town doth demise and lease unto the Society the lands and premises described in Schedule "A" annexed hereto (hereinafter called "the said lands") in the said Town of Mount Forest, for use and occupation for the purposes of the Society, to have and to hold the said lands, demised aforesaid, for a period of Fifteen (15) days in each year for a period of twenty-five (25) years from the date hereof. It is the understanding of the Town of Mount Forest that these fifteen (15) days will be at no cost to the Society.
- 2. Without limiting the generality of the foregoing the Society shall be at liberty to use the building known as the Mount Forest and District Community Centre and kitchen and other facilities contained therein for the duration of the annual Fall Fair sponsored by the Society.
- 3. The Society covenants not to assign or sublet the within lease without the consent of the Lessor.
- 4. The parties hereto shall execute such further assurance as may reasonably be required to carry out the terms hereto.

5. This Agreement shall enure to the benefit of and be binding upon the parties hereto, their successors and assigns and supercedes former agreement dated March 25, 1982.





I was hoping we could come to the same agreement with your food booth for this year's event? I can give you concrete numbers and amounts if you wish, but I know last year the total they donated in sales was about \$ 75.00 and they topped it up to an even \$100.00 donation to our cause. The first year had a larger attendance, and their donation was approx. \$150.00.

In our first 2 years, the event has raised just shy of \$16000 in support of Youth Mental Health, and your donation will help keep the services provided available at no cost to those who so desperately need our help. I would love to be able to count on your support in this endeavor.
