• Mount Forest Aquatics Committee

#### CARRIED

There is currently a funding gap of approximately \$2,500.00 for the Splash Pad project. The site still requires fencing and signage. Water usage at the splash pad was higher than anticipated; staff expect to see reduced water use in subsequent years. The Aquatics Committee will be shifting focus to the Mount Forest Swimming Pool with plans to launch a fundraising program around June 2021.

• Arthur BMX/Skateboard Park

Fundraising efforts continue. The Lions Club received a donation from Wightman Telecom in the amount of \$2,000.00 and on November 26, 2020, the Arthur Lions Club will be hosting a drive-thru Chicken BBQ Dinner at the Arthur Community Centre. The Committee is working with Mr. Cox to virtually meet with his Grade 6 class at Arthur Public School again, gaining perspective, insight and building engagement with the youth.

WAYFINDING SIGNS FOR RECREATION AMENITIES (VERBAL) Staff met with the Mount Forest and Arthur Chambers of Commerce in October to discuss the design and layout options of the wayfinding signage. Based on the feedback received, staff provided Committee with a design for both Arthur and Mount Forest. The signs are the same shape and size, and branding will be individualized to reflect the updated entrance signs in each community. Recreation is working with economic development in identifying recreation and community amenities to be showcased on the signage.

#### BACKGROUND

On October 28, 2020, Ontario announced the COVID-19 Resilience Infrastructure Stream ("COVID stream") under the Investing in Canada Infrastructure Program (ICIP) in Ontario. The federal government has indicated that investments under this stream are to support public infrastructure, defined as tangible capital assets, including temporary infrastructure related to pandemic response, primarily for public use and/or benefit. According to federal parameters, eligible projects include:

- Retrofits, Repairs and Upgrades for municipal, provincial, territorial and indigenous buildings, health infrastructure and educational infrastructure;
- COVID-19 Response Infrastructure, including measures to support physical distancing;

- Active Transportation Infrastructure, including parks, trails, foot bridges, bike lanes and multi-use paths; and
- Disaster Mitigation and Adaptation, including natural infrastructure, flood and fire mitigation, tree planting and related infrastructure.

The federal timelines of this program require all parties to work together quickly to implement funding. Applications will be reviewed and prioritized by the province based on a rolling intake (i.e. first-come, first-served), but the following deadlines will apply:

- Applications for single projects must be submitted to the province through the Transfer Payment Ontario (TPON) system by December 21, 2020;
- Applications for multiple projects must be submitted to the province through the Transfer Payment Ontario (TPON) system by January 7, 2021;
- Projects must have started construction by September 30, 2021; and,
- Projects must have completed construction by December 31, 2021; except for remote communities which will have until December 31, 2022 (see below).

Staff have identified these potential projects for consideration:

- Cork St Playground
- Arthur & Area Community Centre Kitchen
- Mount Forest & District Sports Complex Generator
- Arthur & Area Community Centre Washroom Accessible
- Choker / Accessible Sidewalks

Committee needs to discuss and provide comment / direction to staff about what their preferred project would be for this grant application.

#### FINANCIAL CONSIDERATIONS

Under the new COVID stream, \$250 million in combined federal-provincial funding will be dedicated to local governments across the province. The Township of Wellington North's allocation is \$199,521 for this new stream.

Municipalities will not be required to cost-share under this stream. The federal government will cover 80% of the total eligible costs associated with any approved project and Ontario will cover 20%, however, total eligible costs for all submitted projects cannot exceed your municipal allocation noted above.

#### Re: Investing in Canada Infrastructure Program (ICIP) – COVID-19 Resilience Infrastructure Stream

On October 28, 2020, Ontario announced the COVID-19 Resilience Infrastructure Stream ("COVID stream") under the Investing in Canada Infrastructure Program (ICIP) in Ontario.

Under the new COVID stream, \$250 million in combined federal-provincial funding will be dedicated to local governments across the province. **Your municipality's allocation is \$199,521 for this new stream.** 

The federal government has indicated that investments under this stream are to support public infrastructure, defined as tangible capital assets, including temporary infrastructure related to pandemic response, primarily for public use and/or benefit. According to federal parameters, eligible projects include (see Appendix B for full details):

- **Retrofits, Repairs and Upgrades** for municipal, provincial, territorial and indigenous buildings, health infrastructure and educational infrastructure;
- COVID-19 Response Infrastructure, including measures to support physical distancing;
- Active Transportation Infrastructure, including parks, trails, foot bridges, bike lanes and multiuse paths; and
- **Disaster Mitigation and Adaptation**, including natural infrastructure, flood and fire mitigation, tree planting and related infrastructure.

Municipalities should work with the federal eligibility criteria to identify projects to address COVID-19 responses and resilience, including in municipal/regional owned long-term care homes. Municipalities are also able to partner with not-for-profit and broader public sector organizations (e.g. any public sector body) and submit projects on their behalf, using their municipal allocations. This will be subject to the municipality's own project evaluation prior to submission to the province. Not-for-profits and broader public sector organizations will be available on this in the program guidelines.

As with other ICIP streams, projects that have already commenced construction or contain no capital components (i.e. planning projects) are ineligible for funding under this intake. Additionally, costs for land acquisition, infrastructure for tourism or facilities home to a professional sports team, and any project already nominated to the federal government under another ICIP stream are ineligible under the COVID stream.

Municipalities will not be required to cost-share under this stream. The federal government will cover 80% of the total eligible costs associated with any approved project and Ontario will cover 20%, however, total eligible costs for all submitted projects cannot exceed your municipal allocation noted above.

Municipalities will have the opportunity to submit projects for review and approval, but eligible costs associated with any given project cannot exceed \$10 million.

There will be a project cap based on your municipal allocation:

- 1 project submission for those receiving a maximum of \$100,000;
- 2 project submissions for those receiving \$100,001 to a maximum of \$500,000; and,
- 5 project submissions for those receiving \$500,001 and above.

Projects are limited to one of four categories as outlined by the federal government in the list in appendix B. Please contact our delivery team (email below) if you have questions about this. Municipalities can bundle various assets, within one of the four categories, under one project submission.

The federal timelines of this program require all parties to work together quickly to implement funding. Applications will be reviewed and prioritized by the province based on a rolling intake (i.e. first-come, first-served), but the following deadlines will apply:

- Applications for <u>single projects</u> must be submitted to the province through the Transfer Payment Ontario (TPON) system by December 21, 2020;
- Applications for <u>multiple projects</u> must be submitted to the province through the Transfer Payment Ontario (TPON) system by January 7, 2021;
- Projects must have started construction by September 30, 2021; and,
- Projects must have <u>completed</u> construction by December 31, 2021; except for remote communities which will have until December 31, 2022 (see below).

Only projects that meet the above criteria, as well as those that will follow in the provincial program guidelines will be considered for nomination by the Province to the federal government. No deadline extensions will be considered. If you do not submit your application on time, or your project does not start and/or complete by the deadlines required by the federal government, you will lose any opportunity to access this funding allocation.

As per federal parameters, remote communities will receive additional time and have until December 31, 2022 to complete project construction. Communities who fall under this definition, as per the Canada-Ontario Integrated Bilateral Agreement, are outlined in the attached in Appendix A.

Application materials (i.e. application forms, program guidelines and federal Environmental Assessment/Duty to Consult forms) will become available on the TPON website once the stream has officially launched the week of November 16th. Please check back on the site for updates in the coming weeks.

#### BACKGROUND

Township currently has an existing agreement with the Mount Forest Agricultural Society (MFAS) which expires in April 2021. The existing agreement was established in 1996, between the Town of Mount Forest and the MFAS, and ran for twenty-five years. A copy of the agreement is attached as Schedule A.

Township staff recently met with the MFAS to ensure awareness of the upcoming agreement end date as well as request any items that MFAS wanted to put forward as changes. MFAS response to this request is included in Schedule B.

At that meeting, Township staff made clear that staff would be putting forward several items for Committee / Council consideration during the negotiation.

Township staff would ask Committee / Council to consider the following:

- New term for the agreement, less than twenty-five years, with automatic renewal;
- Provision and mechanism for agreement termination by either party;
- Make MFAS responsible for upkeep of their fencing, buildings and the Western horse grounds to a reasonable standard;

- Detail that MFAS is responsible for their hydro service, this is an existing situation that should be simply defined;
- Include details of the property owned and maintained by the MFAS;
- MFAS to maintain insurance for their property and provide it annually to the Township;
- Vehicle parking at the MFAS central building has been raised as a concern by other users of the Fairgrounds (Schedule C);
- MFAS central building is occasionally (1-2 per year) used for licensed events. Township staff would like these licensed events to follow Township policy / procedure for these events similar to what we expect within our own facilities;
- Detail that use of Victory Church needs to be consistent with the Township's existing agreement with the Victory Church;
- Update the legal descriptions within Schedule A or use more common language to describe these lands;
- Township Council needs to give consideration to their planned future use of these lands during this process;

(hereinafter called the "Society" of the SECOND PART)

WHEREAS the Town is the owner of the lands described in Schedule "A" annexed hereto, and the Society wishes to use the said lands from time to time.

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of the covenants contained herein and other good and valuable consideration the parties hereto agree as follows:

1. The Town doth demise and lease unto the Society the lands and premises described in Schedule "A" annexed hereto (hereinafter called "the said lands") in the said Town of Mount Forest, for use and occupation for the purposes of the Society, to have and to hold the said lands, demised aforesaid, for a period of Fifteen (15) days in each year for a period of twenty-five (25) years from the date hereof. It is the understanding of the Town of Mount Forest that these fifteen (15) days will be at no cost to the Society.

2. Without limiting the generality of the foregoing the Society shall be at liberty to use the building known as the Mount Forest and District Community Centre and kitchen and other facilities contained therein for the duration of the annual Fall Fair sponsored by the Society.

3. The Society covenants not to assign or sublet the within lease without the consent of the Lessor.

4. The parties hereto shall execute such further assurance as may reasonably be required to carry out the terms hereto.

5. This Agreement shall enure to the benefit of and be binding upon the parties hereto, their successors and assigns and supercedes former agreement dated March 25, 1982.




Hello Tom and Tasha,

Below I have attached 4 pictures. Two of the empty parking lot next to the playground with dozens of vehicles in the background parked on and around the fields. In the other two photos: the parking lot next to the recreational centre with 5 vehicles in this exceptionally large parking lot, while dozens of vehicles parked in, on and around the fields.

Your previous emails acknowledged my concerns, but there has been no action taken. Tom, you said that "next summer" you will "try and improve traffic conditions", I think this is completely unacceptable. These pictures were taken from outside the fields because it is clearly too dangerous to use the "walking path". Allowing this to continue as you have only empowers the people continuing to use this path as a road. A few nights ago while walking our dogs, my wife and I were run off the path by a driver who, when confronted, stated "I do this all the time" and sped off. By turning a blind eye to this behaviour you have created a social norm that will be increasingly difficult to stop. Waiting until the summer to enforce the townships policies is just as lazy and dangerous as the people that can't walk 50 feet from the parking lot to the building in the centre of the field. I understand that the agricultural society rents this space and that this is a clearly enticing and profitable relationship. I am not suggesting in any way that this relationship should be affected. All I'm suggesting and pleading with you, is that you enforce the rules set in place to keep the community safe. Enforce the use of the parking lots before someone is seriously injured or worse killed due to this negligence.
