

Civil Marriage Ceremony Guidelines

Civil ceremonies will be conducted by an appointed Marriage Officiant of the Township of Wellington North. Couples wishing to be married must have an Ontario Marriage License and a completed Civil Marriage Ceremony Questionnaire provided by the Township. A request for a civil ceremony must be received at least ten days prior to the date of the ceremony.

Bookings:

At the discretion of the Officiant, Ceremonies can take place at an agreed upon location of your choice, in the Province of Ontario, that is a setting conducive for a ceremony.

Mandatory Marriage Consultation:

The mandatory marriage consultation is to be scheduled (at the time the marriage is booked) 7 to 10 days prior to the date of the ceremony. Both applicants are required to attend a mandatory marriage consultation with the Marriage Officiant.

The applicants should have with them:

Photo Identification (e.g. Driver's License, current Passport or picture Ontario
Health Card)
A completed Civil Marriage Ceremony Questionnaire; and
A valid Ontario Marriage License which can be purchased from the Town or
another Ontario municipality with the authority to issue marriage licenses and is
valid for a period of three months after the issue date.

Fee Schedule:

The fees are set out in the fees and charges by-law passed annually by the municipality.

Fees must be paid in full five days in advance of the ceremony or the ceremony shall not proceed. Fees are payable to the Corporation of the Township of Wellington North and can be made by e-transfer to accounting@wellington-north.com, debit, cheque or cash.

Witnesses:

Two witnesses are required to be present during the ceremony. Although there is no minimum age for a witness, it is suggested that they should be at least 14 years of age

and should be able to understand and appreciate what is taking place and be able to give evidence of such later, if required.

Interpreters:

If you do not understand or read English, you must provide your own interpreter and he/she must provide identification. Expiry Date: A marriage license is valid for use anywhere in Ontario for a period of three (3) months from the date of issue.

Ceremony Options: The couple may review and choose from three ceremony script options. Their selection should be submitted along with the Civil Marriage Ceremony Questionnaire.

Subject to approval by the Marriage Officiant, the couple may personalize parts of the script, including vows. Music deemed by the Marriage Officiant to be appropriate to the occasion will be allowed. The applicants must supply a music player for their recorded music.

PLEASE NOTE: A booking is not confirmed until the Civil Marriage Ceremony Questionnaire is completed and returned to the Municipal office, signed applicants and officiant, and payment of all fees have been received.

Following the Ceremony, you and your spouse will receive:

A congratulatory certificate
A record of Solemnization of Marriage (Please note that this is not a Marriage
Certificate. Some organizations will require a Marriage Certificate as proof that
your marriage was registered by the Province)

NOTE: For your Marriage Certificate apply on-line 90 days after your wedding at www.serviceontario.ca

I do solemnly declare that I do not know of any lawful impediment why I, Partner 1, may not be joined in matrimony to Partner 2.

Partner 2 repeat after me:

I call upon these persons here present, to witness that I, Partner 2, do take you, Partner 1, to be my lawful wedded [husband/wife/spouse], my partner in life, and my one true love.

Partner 1 repeat after me:

As such, marriage is not to be entered upon thoughtlessly or irresponsibly but with a due and serious understanding and appreciation of the ends for which it is contracted.

Partner 1 repeat after me please.

I do solemnly declare that I do not know of any lawful impediment why I, Partner 1 may not be joined in matrimony to Partner 2.

Partner 2 repeat after me please.

I do solemnly declare that I do not know of any lawful impediment why I, Partner 2, may not be joined in matrimony to Partner 1.

Partner 1 repeat after me:

I call upon these persons here present to witness that I, Partner 1, do take you, Partner 2, to be my lawful wedded [wife/husband/partner/spouse]. To laugh with you in joy, to grieve with you in sorrow, to grow with you in love and to be faithful to you alone; as long as we both shall live.

Partner 2 repeat after me:

I call upon these persons here present to witness that I, Partner 2, do take you, Partner 1, to be my lawful wedded [wife/husband/spouse]. To laugh with you in joy, to grieve with you in sorrow, to grow with you in love and to be faithful to you alone; as long as we both shall live.

I ask that the rings you are about to exchange be used and regarded as a seal and confirmation and acceptance of the vows you have made.

Partner 1 repeat after me please.

Receive this ring as a symbol of my vows to you. Whenever you look at it know that I love, honour, and cherish you above all others.

Partner 2 repeat after me please.

Receive this ring as a symbol of my vows to you. Whenever you look at it know that I love, honour, and cherish you above all others.

I, Officiant's Name, by virtue of the powers vested in me by the Marriage Act, do hereby pronounce you Partner 1 and Partner 2 to be married
